### PRAKAS (PROCLAMATION)

on

### APPLICATION OF MODELS OF FISHING VESSEL LOGBOOK

### MINISTER OF AGRICULTURE, FORESTRY AND FISHERIES

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen the Royal Decree No. NS/RKT/0908/1055, dated 25 September 2008 on the Appointment of the Royal Government of Cambodia;
- Having seen the Royal Kram No. 02/NS/94, dated 20 July 1994, promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen the Royal Kram No. NS/RKM/0196/13, dated 24 January 1996, promulgating the Law on Establishment of the Ministry of Agriculture, Forestry and Fisheries;
- Having seen the Royal Kram No. NS/RKM/0506/011, dated 21 May 2006, promulgating the Law on Fisheries;
- Having seen the Sub-Decree No. 17 OrNKr.BK, dated 07 April 2000 on the Organization and Functioning of the Ministry of Agriculture, Forestry and Fisheries;
- Having seen the Sub-Decree No. 188 OrNKr.BK, dated 14 November 2008 on Re-arrangement of the Directorate General within the Ministry into Secretariat General, Promotion of the Forestry Administration and the Fisheries Administration to have equal rank to Directorate General, Promotion of Department of Agronomy and Agricultural Land Improvement to be Directorate General of Agriculture, and Re-arrangement of Directorate General of Rubber Plantation to be Directorate General of Rubber under the Management of the Ministry of Agriculture, Forestry and Fisheries;
- In response to the request made by the Delegate of the Royal Government of Cambodia in charge of Director General of the Fisheries Administration

### HEREBY DECIDES

- Article 1: Application of the model of fishing vessel logbook with an aim to manage and monitor the activities of fishing vessels involving in all categories of fishing businesses. The logbook is annexed to this Prakas.
- Article 2: All fishing vessels with loading capacity of over 500 kilograms shall comply with the requirements as stipulated in the fishing vessel logbook to ensure safety, waterway orderliness, and lives of fishermen.

- Article 3: The model of fishing vessel logbook has a light blue cover with Cambodian Fishery Logo in a diameter of 110 millimeters. The logbook is distributed free of charge by the Fisheries Administration.
- Article 4: The fishing vessel logbook shall be securely kept by each captain to avoid tearing or loss of any pages and presented to an authorized fishery agent at each time of inspection. In case of loss, the captain is required to immediately report to fishery authority in order to request a new logbook.
- Article 5: Anyone who counterfeits the fishing vessel logbook or fails to comply with contents as stated in the Prakas shall be punished pursuant to the existing laws.
- Article 6: Prakas or any decisions which are contrary to this Prakas are annulled.
- Article 7: Secretary General, Inspector General, Cabinet Chief, Department Chief of Agricultural Legislation, Department Chief of Administrative Affairs, Department Chief of Planning and Statistics, Department Chief of Accounting and Finance, and Chief of the Fisheries Administration shall be responsible for the effective implementation of this Prakas according to their respective duties from this signing date.
